The G20 summit is at the forefront and MTDC has learnt that the working group meetings of the same are scheduled in Mumbai and Pune as follows:

The Department of Tourism opines that international standard tour packages of Maharashtra for G20 countries be curated by tour operators recognised by IATO / MOT/ ADTOI/ATOAI, in association with MTDC. The tour packages be designed on following themes / circuits.

Mumbai/Pune – Nagpur – Tadoba Andhari Tiger Reserve – Pench Sillari National Park – Nagpur – Mumbai/Pune.

2. UNESCO World Heritage sites Tour:

Mumbai/Pune – Aurangabad – Ajanta & Ellora Aurangabad – Mumbai/Pune.

3. Marvels of Maharashtra: 6N/7D

Mumbai (Elephanta) – Nashik (Trimbakeshwar, Harihar fort, Sula Vineyard, MIDC Nashik Boat Club, Grape Park Nashik) – Ellora WHS – Aurangabad – Ajanta – Nagpur (Tadoba and Pench Sillari) – Mumbai.

4. The Beach Coastal Experience: 3N/4D

Mumbai/Pune – Tarkarli – Ganpatipule – Mumbai/Pune.

5. Discover Pune four

Mumbai/Pune – Pachagani-Mahabaleshwar – Agro Tourism Experience – Lonavala Heritage and Culture of Pune – Mumbai/Pune

6. Nashik The Wine Capital Tour: 2N/3D

Mumbai/Pune – Sula Vineyard – Jhumpa – Mumbai/Pune

7. Nashik The Spiritual Connect Tour: 2N/3D

Mumbai/Pune – Trimbakeshwar – Panchavati – Shirdi – Mumbai/Pune.

10. Mumbai Magic: A Day Tour

Mumbai CSMT with local train tour – Victorian & Art Deco Ensembles of Mumbai - Marine drive – Chaupatty – Mani bhavan.

11. Intangible Cultural Heritage like Ganpati festival, Pandharpur Vari yatra.

12. Bollywood tour.

13. Other experiences like Heritage Walks, MTDC Mahabhraman experiences like Govardhan Eco-Village Wada, Saguna Bang, etc

While designing the tour packages it is requested that following be ensured:

1. Tours be designed for the most up-class market using 4 Star and above Properties.
2. Properties of MTDC be used at Tadoba, Ganpatipule, Tarkarli, Mahabaleshwar and Nashik.
3. Air transport be used as much as possible.
4. State of the art buses be provided.
5. Guides registered with MoT, GoI be ensured.
6. The tour packages be made all inclusive with guides, entry fees, tolls, etc. except Personal care, laundry, phone calls, shopping, etc.

The contention is to make these packages available online for booking for the G-20 delegates, and also to market these tours in G-20 countries through the Indian Missions Abroad.

MTDC being a Corporation has been assigned a commercial role by the Department of Tourism, Government of Maharashtra. Hence, MTDC may charge a small commission (**less than 10%**) from business generated through this promotional platform being facilitated by MTDC. The engagement with MTDC for the above mentioned promotions along with commission rates (less than 10%) will be valid for one year (until December 2023). The tour operator(s) operating this packages in association with MTDC shall be required to pay MTDC its commission accordingly.

With this in mind, it is requested that the tour operators carrying mandatory recognition mentioned above may submit packages based on the given themes/circuits on following E- mail businessdevelopment@maharashtratourism.gov.in by 1st November, 2022.
