#### 2. PREAMBLE

- 1.1 Maharashtra Tourism Development Corporation Ltd. Mumbai, hereinafter referred as Employer, is a Public Sector Undertaking fully owned by the Government of Maharashtra.
- 1.2 Maharashtra Tourism Development Corporation Ltd. (MTDC Ltd.), (A Government of Maharashtra Undertaking), invites proposals in form of expression of interest (EOI) for Empanellment of Agencies to provide comprehensive services related to organising Tour Packages on various routes with all facilities. The empanelled agency shall provide the services as and when required for three years period plus extendable up to two years on satisfaction.
- 1.3 In this context, MTDC LTD. Mumbai proposes to empanel various "Tour Package Operators" for executing MTDC Tour Packages using MTDC Resorts / Units.

#### 3. INFORMATION TO APPLICANTS:

#### a) Basic information of Applicants:

- 3.1 MTDC Ltd invites Proposals against this Expression of Interest ("EOI") for empanellment as "Tour Packages/Travel Services Provider Agencies" as and when required by Tourists / MTDC for three years period plus extendable up to two years on satisfaction.
- 3.2 The empanellment of successful Agency shall be based on the Quality and in mations offered in Tour Packages.
- 3.3 The proposals shall be received in e-procurement mode, through the portal www.mahatenders.gov.in.
- 3.4 Proposals must be received not later than the time, date at the venue mentioned in the notice. Proposals received after the deadline will not be considered in this empanellment process.
- 3.5 Interested Agencies are advised to study the EOI document carefully. Submission of response shall be deemed to have been done after study and examination of the EOI document with full understanding of its implications.
- 3.6 Empanellment documents shall be downloaded from our Maharashtra Tourism Development Corporation Ltd. Mumbai's website at https://mahatenders.gov.in.
- 3.7 Application form for Empanellment shall be submitted in sealed envelope super scribing "Application for Impanelment of "MTDC Tour Package Operator", **on or before stipulated time and date.** Uploaded on https://mahatenders.gov.in.

- 3.8 The application shall be submitted only as per the enclosed format (s) along with Annexure I to IX. Self-attested documentary proof(s) in respect of the details furnished in the application form shall be submitted along with the application. The intending applicants shall also submit the list of such projects where due to any disputes, litigation/arbitration was invoked and or the "Tour Package Operators" were abandoned/suspended by the Client. Suppression of any information in this regard may lead to cancellation of Empanellment of the "Tour Package Operator" concerned, if such information comes to the notice of MTDC LTD. MUMBAI after Empanellment. Incomplete applications will be summarily rejected.
- 3.9 The application shall be signed by the authorized person (s) of the firm. All pages of the documents shall be signed / sealed.
- 3.10 The EoI by applicant for individual category shall be opened preferably on **last date** submission at 4:00 pm, if possible.
- 3.11 MTDC LTD. MUMBAI. Reserves the right to reject any or all applications without assigning any reason thereof.
- 3.12 The Empanelment of "Tour Package Operator" will be for a period of 3 years or till fresh Empanellment is done whichever is earlier.
- 3.13 Prequalification/Empanellment does not necessarily mean that a job will be assigned to the "Tour Package Operator".
- 3.14 Clarifications, if necessary, will be sought from the applicants before Empanellment. All information submitted by the applicants during the process of Empanellment will be the property of MTDC LTD. MUMBAI and will not be returned.

#### b) General Information about Tender:

- 3.15 The bid should contain all the relevant information and desired enclosures in the prescribed.
- 3.16 The tender should be submitted through e-Tendering / e-Procurement portal www.mahatenders.gov.in or to the MTDC Head Office at Mumbai as provided in this document. No other form of tender submission will be valid for evaluation.
- 3.17 All information called for in the enclosed forms should be furnished against the respective columns in the forms. If information is furnished in a separate document, reference to the same should be given against respective columns in such cases. If any particular query is not applicable, it should be stated as "Not Applicable". However the Agencies are cautioned that not giving complete information called for in the tender forms or not giving it in clear terms or making any change in the

- prescribed forms or deliberately suppressing the information may result in the Agency being summarily disqualified.
- 3.18 The tenders without EMD shall be summarily rejected. No exemption for EMD will be entertained. The successful Agency shall be required to deposit performance security in form of bank guarantee valid for the contract period plus three more months within 15 days from the date of the Empanellment. The EMD of the unsuccessful Agencies shall be returned without interest after award of work to the successful Agency. The EMD of the successful Agency shall be returned only after the signing of the agreement along with performance security deposit. The EMD stands forfeited in case the Agency withdraws or amends his bid after submission of tender document.
- 3.19 Reference, information and certificates from the respective clients certifying technical, delivery and execution capability of the agency should be signed and the contact numbers of all such clients should be mentioned. MTDC Ltd may also independently seek information regardingthe performance from the clients.
- 3.20 The applicant is advised to attach any additional information, which they think is necessary in regard to their capabilities to establish that the applicant is capable in all respects to successfully complete the envisaged work. They are however, advised not to attach superfluous information. No further information will be entertained after tender document is submitted, unless MTDC Ltd calls it for.
- 3.21 Even though Agency may satisfy the qualifying criteria, they are liable for disqualification if they have a record of poor performance or not able to understand the scope of work etc.
- 3.22 Prospective Agencies may seek clarification regarding the project and/ or the requirements for prequalification, in writing through mail within a reasonable time or in the pre bid meet.
- 3.23 All disputes arising shall be subject to the jurisdiction of appropriate court of Mumbai alone and shall be governed by the law of India. MTDC Ltd reserves right to award the work / cancel the award without assigning any reason. In case of differences, if any, the decision of MTDC Ltd shall be final. Initially the agreement will be for three years and may be extended for two more year depending upon successful completion of the job, performance review and mutual agreement.
- 3.24 The successful Agency has to sign an agreement on non-judicial stamp paper which shall contain clauses related to liquidated damages on account of delays, errors, cost and time over runs etc.
- 3.25 Agencies are neither allowed to join hands to participate in the tender as a consortium nor allowed to submit multiple bids. Any such act will make the bid liable for rejection.

#### 4. INSTRUCTIONS TO APPLICANTS:

#### 4.1 GENERAL

- a) All information requested for in the enclosed forms should be furnished against the respective columns in the format. Applicants are cautioned that non submission of complete information as per the required formats or making any change in the prescribed forms may result in the application being summarily rejected.
- b) The application shall be type written. The applicant's name, signature and stamp shall appear on each page of the application form.
- c) The application form as downloaded from the website of MTDC LTD. MUMBAI. https://mahatenders.gov.in.
- d) Copies of the References, information, work orders and completion certificates from the respective clients certifying the suitability, technical knowhow, experience or capability of the applicant shall be submitted by the applicant, which could be verified by MTDC LTD. MUMBAI., when required.
- e) The cost incurred by the applicants in preparation & submission of this application, providing clarifications or attending discussions in connection with process of Empanellment shall be borne by the applicant and MTDC LTD. MUMBAI in no case shall be responsible or liable for these costs regardless of the outcome of the process.

#### 4.2 DEFINITIONS

- a) In the document, the following words and expressions shall have the meaning hereby assigned to them except where the context otherwise requires:
- I) "MTDC/Tourist" means Maharashtra Tourism Development Corporation Ltd. Mumbai.(MTDC LTD., MUMBAI.) and include the Tourists who has booked the package, MTDC's representatives or successors, but not without the consent of the Contractor any assignee of the Employer.
- II) "Applicant" or "Tour Package Operator" or "Agency" or "Firm" means proprietary firm, Partnership firm, Private Limited Company, Limited Company whose application has been received by the employer and includes the applicant's personal representatives, successors and permitted assignees.

#### 4.3 METHOD OF APPLYING

- a) If the application is made by a proprietary firm, it shall be signed by the Proprietor above his full typewritten name and full name of his firm with the current address.
- b) If the application is made by a firm in partnership, it shall be signed by all the partners of the firm above their full typewritten names and current addresses or alternatively by a partner holding Power of Attorney for signing the application, in which case a certified copy of Partnership Deed shall accompany the application.
- c) If the application is made by a Limited Company, it shall be signed by a duly authorized person holding the Power of Attorney for signing the application, in which case a certified copy of the Power of Attorney issued by the Board of Directors shall accompany the application.

#### 4.4 FINAL DECISION MAKING AUTHORITY

a) The "MTDC" reserves the right to reject or accept any one or all applications and to annul the process and reject all the applications at any time without assigning any reason(s) thereof and without thereby incurring any liability to the affected applicant or without informing the applicants of the grounds for the MTDC's action.

7.3 Agencies should satisfy the qualifying criteria on their own merits and not as a sum total of their sub agencies. Joint Ventures / Consortium / MOU shall not be entertained. All documents be mandatory attested for above.

#### **8. EMPANELLMENT:**

- 8.1 Based on the maximum marks obtained/scored in each individual category, the "Tour Package Operator having scored equal to total 75 marks & above, shall ONLY be considered for empanellment. Other Tour Package Operator those who score less than total 75 marks shall not be considered for empanellment. No correspondence shall be done with the Tour Package Operator who are not empanelled. Also no claims of any kind or queries in any form shall be entertained.
- 8.2 The empanellment of "Agencies for operating MTDC Tour Packages" will be for a period of 03 (Three) Years from the date of announcement of empanellment. However, MTDC LTD. MUMBAI reserves the rights to cancel or extend the empanellment of any or all the consultant and request afresh proposals for empanellment at any time.
- 8.3 MTDC LTD. MUMBAI reserves the right to extend the period of empanellment of consultants for a further period of two years depending on the requirement and performance of the consultant. The decision of MTDC LTD. MUMBAI in this regard shall be final.
- 8.4 The empanellment of "Tour Package Operator" will remain in force for the purpose of completion of all MTDC Tour Packages during the period of the empanellment until they have been completed.
- 8.5 MTDC LTD. MUMBAI reserves the right to withdraw/ cancel empanellment observing the performance of the services before the period of empanellment is over.

#### 9. ALLOTMENT OF WORK:

9.1 Depending upon the requirement, MTDC LTD. MUMBAI, from all the empaneled entities, shall invite detailed plans with the Tour design for the said Tour Packages and based on the quality of Tour design in consultation with Regional Manager, the Tour proposal and cost, will be evaluated by panel of MTDC and the Tour will be given for

- operation, i.e. one "Tour Package Operator" will be selected based on the above parameters.
- 9.2 The Tour Package will be allotted to the successful "Tour Package Operator", who is empanelled based on the stipulations as mentioned in 9.1 above. Payment structure of the fess shall be as given in 13 below.
- 9.3 MTDC LTD. MUMBAI also reserves the right to allot the Tour Package to any of the empanelled "Tour Package Operator" after giving due consideration to the suitability and competence of the "Tour Package Operator" to handle jobs, with due regard to their proven track record, which shall be reviewed by MTDC LTD. MUMBAI/ Regional Manger. (MTDC), as found necessary, from time to time.
- 9.4 The "Tour Package Operator" who are awarded the work shall have to enter in to the agreement in the standard format of MTDC.
- 9.5 MTDC Ltd., Mumbai doesn't guarantee for getting the job/ work/assignment to the empanelled "Tour Package Operator" during Empanellment period. No claims of any nature (including financial claims) shall be tenable in any case.

#### **10.** Litigation History

10.1 The Applicant should provide accurate information on any litigation or arbitration resulting from contracts completed or under its execution over the last Five (5) years ending 31.03.2022. A consistent history of litigations against the Applicant may result in disqualification of the application for Empanellment, at the discretion of MTDC LTD. MUMBAI.

#### 11.Disputes

- 11.1 All disputes of any nature shall be first submitted to the Managing Director, MTDC Ltd Mumbai whose decision shall be final and binding.
- 11.2 Jurisdiction of Court in case of dispute not resolved will be Head Office, Mumbai.
- 11.2.1 Any suit or application, arising out of any dispute or difference on account of this prequalification tender shall be filed in a competent court at Mumbai only and no other court or any other district of the country shall have any jurisdiction in the matter.

## 12. BROAD SCOPE OF WORK / SERVICES TO BE PERFORMED BY "EMPANELLED TOUR PACKAGE OPERATORS"

### **Background of scope of work (The Concept)**

- To follow all rules and regulations prescribed by transport department.

- To follow all rules and regulations as laid down by local and Govt. Authorities from time to time.
- To display MTDC partnership for these packages at all times.
- The Agency shall ensure suitable drinking water and separate toilet facilities for both men and ladies during tour (enroute to MTDC Resorts & Sightseeing)

The MTDC shall reserve the right to be modified /changed/added new routes/packages at any time as deemed think fit.

TOURIST FOCUS: The Tourist comfort, safety, security and esteem should be taken as priority. *Atithi Devo Bhava* would be displayed through a proper Reception and Welcome of the Guests that shall include traditional welcome, aarti, tikka and garland. The guest shall be provided with a Single point of contact, who will be appointed by the MTDC Regional Manager or the Head Office.
